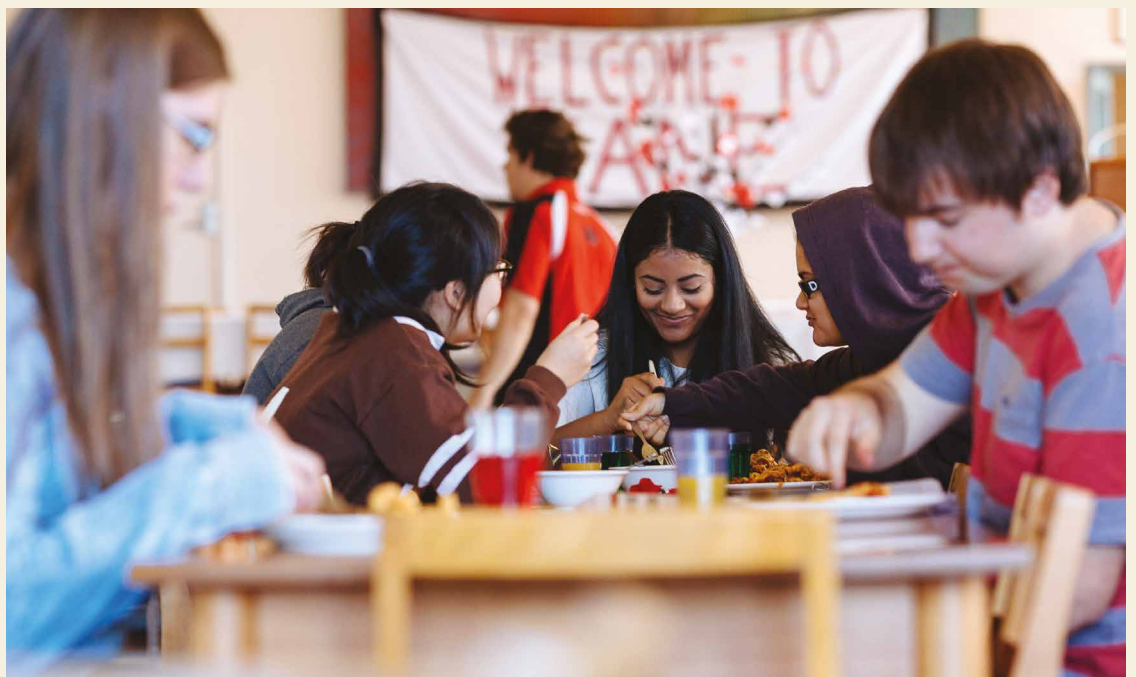
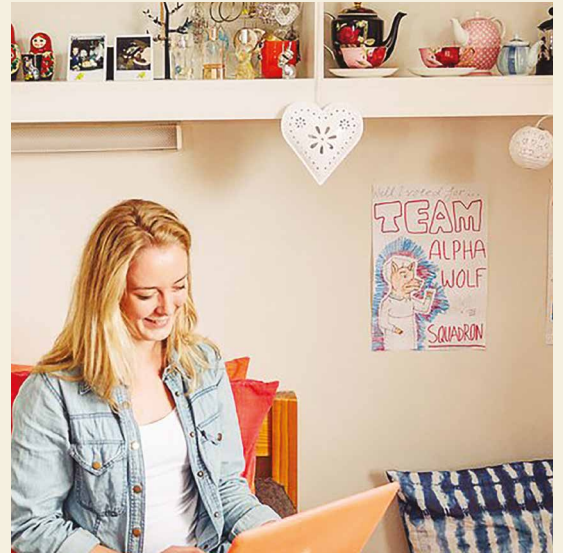
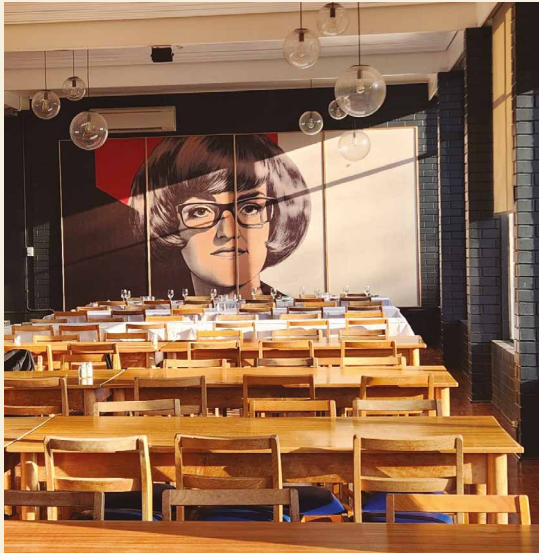

Explanation of Fees

Application Fee

This is a non-refundable fee, payable upon application to the College and covers the administration costs of processing applications. It must be paid before your application can be considered.

Acceptance Fee

To secure your place at the College, you are required to pay an Acceptance Fee. The Acceptance Fee is non-refundable, should you accept your offer and then withdraw for any reason.

Room Bond

- If you are a new resident, you are required to provide a Room Bond. The Room Bond is retained by the College until the termination of your Residential Contract and shall be refunded to you - minus an Alumni Association fee – should you meet all the conditions of your Residential Contract.
- The College reserves the right to deduct from the Room Bond any amount deemed by the College to be payable by you, due to your breach of any contractual conditions.
- The Room Bond is payable upfront, which is paid the first time you enter the College and carried over into subsequent years of residency.
- The Room Bond can be claimed by completing a form available from the office anytime or our website after permanently leaving Jane. Please note that the Room Bond cannot be refunded without the submission of this form.
- The Room Bond can be claimed up to one (1) year after departure from Jane. If not claimed in that time the Room Bond will be considered forfeited and will be transferred to the College's Community Scholarship Fund to support future students.

Alumni Association Fee

This fee of \$50 is deducted from your Room Bond upon leaving College and is non-refundable. It supports alumni activities.

Building Levy

The Building Levy supports the ongoing maintenance and improvement needed for our College infrastructure. It is non-refundable. The Building Levy is payable upfront.

Student Club Membership Fee

Student Club Membership Fees are collected by the College and passed onto the Jane Student Club Committee for allocation towards social, sporting and cultural activities. The fee is non-refundable and payable upfront.



Explanation of Fees

Accommodation Fees

Accommodation Fees are payable in a number of ways and cover:



Provision of a study bedroom with a bed and room furniture



Full board with 21 meals per week



Water, electricity, gas & heating



Academic Development Program including Academic Mentoring and Tutoring



Support from the Dean of Students, Dean of Academic Studies, Senior Residents, Academic Mentors and other staff



Unlimited WiFi



Access to the UTAS UniHopper bus service



24 hour access to laundry washing machines and dryers

Accommodation Fees do not cover:

- Cleaning of rooms
- Personal items (toiletries, mobile phone costs, clothes etc)
- University fees
- Books and stationery
- Printing and photocopying
- Linen
- Room bond and other fees



Residential Contract

Contract Options

Residents may choose between the following standard contract durations:

**38
WEEK**

A 38-week contract, covering Semester One and Semester Two of the academic year.

**52
WEEK**

A 52-week contract, covering Semester One, Semester Two, and the Summer Trimester.

Variations to Standard Contracts

Contract durations may be adjusted in specific cases, including for:

- Students enrolled in the IPC program
- One-semester exchange students
- Students completing their degree in a single semester
- Students commencing enrolment for Semester 2
- Underage international students, whose contracts must extend at least until the end of the semester when they turn 18

Additional weeks can also be arranged for residents enrolled in non-standard semester programs, or for those who wish to arrive early or stay beyond the contracted period.

Self-Catering Option (only available for postgraduate students)

A limited number of self-catering places are available for postgraduate students. For more information, please contact the College office.

Fee Obligations

Residents are required to pay fees for the full duration of their Residential Contract, regardless of whether payment is made in full or through a Direct Debit Request (DDR) instalment plan.



Discounts

Accommodation Fees

- For students returning to stay at Jane for a third or more year, we offer a 10% discount.
- For siblings enrolled in the same year at Jane, we offer a 10% discount for the second sibling.
- For children of Jane Alumni, we offer a 10% discount.
- For those who pay a 38-week contract upfront by C.O.B **29th January 2027**, we offer an Early Bird discount of \$500.
- For those who pay a 52-week contract upfront by C.O.B **29th January 2027**, we offer an Early Bird discount of \$750.
- Residents who pay their semester fees in full by the following deadlines are eligible for an Early Bird Discount of \$200 per semester:

Semester 1: Payment received in full by Close of Business, **29th January 2027**.

Semester 2: Payment received in full by Close of Business, **18th June 2027**.

For those enrolled in the Summer Trimester, an Early Bird Discount of \$200 also applies if full payment for the trimester is received by **22nd October 2027**.

- International students are not eligible for the Early Bird discount in respect of the initial upfront one semester fee required at the time of application. However, the Early Bird discount will be available on a limited basis to international students who pay their full-year contract fees (38 weeks or more) upfront at least four (4) weeks prior to arrival, with the applicable discount being \$500.
- Students who have received a scholarship from Jane will not be eligible for Early Bird fee discounts or any other discounts.
- Students may only claim one discount. Should a student be eligible for two discounts (eg Alumni discount and an Early Bird discount), only the greater discount will be applied.
- Students who are approved to a self-catered contract will not be eligible for the Early Bird discount or any additional discounts including scholarships.
- If an Early Bird or any other discount is deducted from a fee payment prior to the awarding of a scholarship, the discounted payment or credit is required to be repaid by the student or reversed to a student's account. It will automatically be added as a charge to the student's account.



Payment Methods

Contract Options

We offer three ways to pay:

PLAN A

One single payment of all accommodation fees for the year. An Early Bird discount applies if payment is made by 29th January 2027. Payment can be made by bank transfer, EFTPOS or credit card.

PLAN B

Two payments (one per semester) or three payments (one per semester and one per trimester). Early bird discounts apply if payments are received by the dates mentioned under “Discounts”. Payment can be made by bank transfer, EFTPOS or credit card.

PLAN C

Fortnightly direct debit instalments via credit card or bank account. Available only for domestic students.



Payment Methods

Payment Terms

- International students are not eligible for the Early Bird rate, or the DDR facility.
- International students are required to pay all semester fees upfront upon acceptance of a place at the College.
- Direct Deposit (DDR) Payments are paid fortnightly. To pay by DDR, download a DDR Agreement and a DDR Schedule from the Forms Directory on the Jane website <http://www.jane.edu.au/forms-downloads/> complete and return them with Acceptance Fees.
- DDR payments commence on **3rd February 2027**. Where a request to pay by DDR is made after this date, the next scheduled payment will include all prior DDR amounts.
- Dishonoured DDR payments will incur a fee from the College of \$20 to repeat the authorised request for funds. The charge will be repeated for every occasion on which the DDR is not successful due to any errors on your part. If you need to make alternative arrangements, please advise the Accountant, Trammie Cai, prior to the DDR date.
- Should an international student be unable to gain a visa to study in Australia, fees will be refunded with the exception of the Acceptance Fee and Application Fee.
- For international students non-payment of fees by the due date may have consequences for visa retention.
- Sundry items include academic gown, linen pack, lost key fee, car parking fee, fines, pre-Residential Contract accommodation, College merchandise etc. They can be paid for in cash, credit card, EFTPOS or added to a student's invoice.
- Any bank charges incurred from international financial transfers will be the responsibility of the student and charged to the student's account.

Overdue Accounts

- Unpaid accounts will be forwarded to a debt collection agency for recovery. Any expenses incurred by the College in recovering the debt, will be added to your account.
- Overdue accounts will accrue late payment fees of \$35 a week from the due date until the monies are paid. To avoid incurring this fee, we encourage you to discuss your financial position with our Accountant as early as possible.



Withdrawal from College

Withdrawal Terms

- The College will release you from your Residential Contract providing eight weeks' notice is given and a withdrawal fee of \$2,400 is paid. Should a student wish to leave before the eight-week notice period, the College will require the student to pay-out the notice period. Students who withdraw to undertake a study abroad semester are no exception to the withdrawal conditions.
- If you received an Early Bird fee discount and you withdraw before your contract ends, you will be required to refund to the College the amount of the discount.
- Should you withdraw from the College before your contract ends, any scholarships you hold will be forfeited. Scholarships will not be reinstated if you choose to return to Jane at a later date.
- Any intentions to withdraw must be discussed with the Dean of Students before the College agrees to release you from a Residential Contract.
- All outstanding financial matters must be settled before departure.
- Any refund of fees will be processed once a student has vacated their room and on the completion of a room inspection.
- The College may revoke your Residential Contract under the following conditions:
 - i. upon a determination by the College that you should be expelled with immediate effect. In such circumstances you will be charged the withdrawal costs and the balance of any refundable fees already paid to the College will be refunded to you from the actual day of departure; or
 - ii. by the giving of eight weeks' notice, in writing, by the College to you. In such cases the balance of any refundable fees already paid to the College will be refunded to you from the actual day of departure.
 - iii. upon determination by the College that it cannot provide adequate support for health, including mental health, concerns. In such cases the balance of any refundable fees already paid to the College will be refunded to you from the actual day of departure.
- In the event of withdrawal from the College with an intention to return in the future, you are still required to pay penalties. However, the College may agree to discount the penalty amounts from future fees.



Useful Information

FAQs

- All fees are payable by the due date unless otherwise agreed with the College.
- All upfront fees are to be paid before your commencement at College and before scheduled DDR payments commence.
- Regardless of whether you remain in residence, leave early, or take a holiday, you remain responsible for the full amount of your fees for the duration of your Residential Contract.
- No partial or full remission of fees is offered for those who are absent from College for any reason.
- All correspondence and accounts relating to your residency will be directed to your nominated billing address.
- Statements are supplied electronically to you from time to time via your nominated email address. However, you can request a statement at any time. If you do not understand any part of your account, you should ask the Accountant.
